Applications for 2010-2011 school transportation for pupils residing in the Brighton Central School District who attend private and parochial schools must be filed on or before **June 1, 2010** (except where a family moves into the district after **June 1, 2010** in which case application must be made within 30 days after establishing residence in the district). Brighton Central School District transportation policy provides transportation for pupils in grades K-6 who live more than ¼ mile from school and grades 7-12 who live more than ¾ mile from school. There is a fifteen-mile maximum for students attending private and parochial schools. Transportation is provided on an equal basis to pupils in the public schools and those attending private and parochial schools. **It should be noted that even though a pupil is now being transported by the district, a new application must be submitted if transportation is again desired for the following school year. Forms must be submitted to the Transportation Department before service can be provided.** It is critical we be notified in writing of any change in busing. Allow **30 days** to process the request.

ANY FORMS NOT RECEIVED BY JUNE 1, 2010 WILL NOT BE PROCESSED UNTIL AFTER THE START OF THE SCHOOL YEAR, AND TRANSPORTATION WILL BE PROVIDED ONLY IF AT NO ADDITIONAL COST TO THE DISTRICT!
